# Expression of Interest for implementing CCTV cameras and biometric based access control system:

This EOI is being floated by the Biotechnology Research and Innovation Council-National Institute of Biomedical Genomics (BRIC-NIBMG), a premier Autonomous Institute of Govt. of India to gather information/knowledge about solutions being offered by identifying organizations/vendors/solution providers who are willing to participate in setting up cable network-based CCTV cameras and Biometric (Face & Fingerprint) based access control systems for various labs in the main building and a centralized software-based system to manage all these equipment over the campus network.

## SYSTEM DETAILS:

## **Tentative quantity:**

107 Dome Cameras, 43 Bullet cameras, 17 LABs, Software with licenses, cable, connectors, accessories.

#### System capabilities:

- a) The solution should be capable of collecting biometric information of an individual from any computer in the campus network using a Centralised software-based application.
- b) The solution should be capable of restricting/allowing access to an individual to a particular LAB under this solution from any computer in the campus network using a Centralised software-based application.
- c) Emergency exit should be considered for each LAB under this solution.
- d) Capable of running in manual mode in case of software/network/system/power failures.
- e) Capturing the activities happening inside the LABs / Outside LABs (Corridor and Common places) from suitable angles by installing appropriate cameras as per requirement of the Institute.
- f) Providing information about the usage of resources, entry/exit of personnel inside the LABs, etc.
- g) Recognise a person by using biometric information both face and fingerprint.
- h) Running 24x7x365
- i) Keeping CCTV footage for a period of one month.
- j) Registration of users using the centralised software system.
- k) Data backup and restore (software configuration files, biometric information of users, logs) facility.

## **PROPOSED SCOPE OF WORK:**

- Supply and installation of cable networked-based CCTV cameras by Service Provider/OEM with onsite comprehensive warranty support for 3 years from the date of successful installation and commissioning.
- Supply and installation of cable network-based Biometric (Face & Finger) Access control system for LABs and Fire safety protocol by Service Provider/OEM with onsite comprehensive warranty support for 3 years from the date of successful installation and commissioning.

- Supply and installation of a Centralised software-based application for managing Access control system for LABs and CCTV cameras by Service Provider/OEM with onsite comprehensive warranty support for 3 years from the date of successful installation and commissioning.
- Registering biometric information for all the existing staff and students at the Institute to this new centrally managed Access control system either individually **OR** by pulling/collecting biometric data from the existing biometric attendance management system of the Institute.
- Provide adequate hands-on training to the staff of the Institute.
- A complete training material (files, videos, etc.) must be created and handed over by the prospective bidder/service provider.
- Handover software and licenses after successful implementation.

# ELIGIBILITY FOR PARTICIPATION IN EOI:

1. The bidder/OEM must have completed a minimum of three similar works (cable networked based CCTV cameras, Access control systems, centralised integrated software system) in government funded institutions or reputed private organization within India within the past 5 financial years.

# **EOI MUST INCLUDE:**

The detailed and in-depth technical presentation of the solution proposed in EOI will be done in either online or in-person mode if the bidder is shortlisted.

# 1) A project proposal which includes:

- i. Make, model, technical datasheet and feature of the components including software,
- ii. Unit price of each hardware components, software components, software licenses, 3 years on-site comprehensive warranty, etc.
- iii. Estimated total cost based on project proposal.
- iv. Tentative design layout.
- v. Details of after-sale support services.

2) Proposed Timeline: Project needs to be completed within 3 months of the issue of WO.

**3) Proof of credibility of the firm:** Proof of experience as per eligibility criteria. Copy of the orders and completion certificates must be attached.

4) Firm details: Link of the website, where physically located, manpower employed, GST number, etc.
