- 14. DISQUALIFICATION OF CANDIDATE FOR APPOINTMENT TO THE SERVICE ON REGULAR BASIS / DEPUTATION OR ENGAGEMENT ON CONTRACT BASIS AT ANY POINT OF TIME IF THE PERSON
