Expression of Interest for landscaping and development of garden area at NIBMG-Kalyani

National Institute of Biomedical Genomics (NIBMG), a premier Autonomous Institute of Dept. of Biotechnology, Ministry of Science & Technology, Govt. of India desires to clean and create a landscaped garden area in its campus located at Kalyani, West Bengal. Hence NIBMG invites Expression of Interest (EoI) from eligible firms interested in developing this area.

Facility details:

An aesthetically pleasing garden area will be constructed near the main gate campus area of approximately 32000 sq ft [square feet] (refer the attached drawing, shaded area). The area must be designed keeping in mind (a) ensuring that no trees above 15 ft in height growing in that area are cut, (b) making sure that all waste rubble and concrete structures are removed (c) area must include permanent flower beds (two-six), (d) garden paths with paver blocks or similar arrangements that will allow use of the garden in rainy season, (e) sufficient decorative lighting suitable for the garden and garden path, (f) garden benches (eight), (g) garden access from all 3 sides of the designated area, (h) garden area should be covered with appropriate lawn quality grass, except for the area of the garden path and permanent flower beds. Aesthetically pleasing artificial hillocks with fountain with manmade permanent water bodies for plantation of aquatic plants with interlocking tile base should also be included in the proposed plan.

Scope of work [Presentation should be submitted at the time of submission of EOI]

- 1. Cleaning of designated area and soil turnover/replacement
- 2. Landscaping
- 3: Plantation of flower beds, plants, grass, decorative shrubs as per design
- 4: Laying of garden paths with paver blocks/suitable material
- 5. Installation of lighting, benches
- 6. Creation of hillocks and/or man-made permanent water bodies with interlocking tile base.

EoI must include:

- 1) Architectural layout: Detailed design and drawing showing different areas and zones.
- 2) **Project proposal**: Include the estimated cost based on the above proposed requirement.

3) **Proposed Time-line**: Entire project needs to be completed within 3 months of the issue of PO.

4) **Proof of credibility of the firm**: Proof of experience of landscaping/ garden development in a government funded institute/PSU/hospitals/reputed private organization in India must be produced (Copy of the order).

5) **Firm details**: Link of the website, where physically located, manpower employed, GST number.

Eligibility for participation in EOI:

Firms must have experience of in any government funded institution/PSU/hospitals or reputed private organization within India within the past 5 years.

Other information regarding EOI:

1. All EOIs need to be submitted in the email address: ecmc@nibmg.ac.in

2. Prospective bidders can visit NIBMG to inspect the site with prior appointment by writing in the above-mentioned email address.

3. All bids received within the last date specified in the advertisement for EOI will be screened and evaluated by NIBMG.

4. The successful bidders will be asked to make a technical presentation to NIBMG. At this stage a 2D or 3D visual presentation is desired.

5. Only the successful bidders in the EOI will be allowed to take part in the two-stage tendering process to be done in CPPP portal.
