TENDER FOR THE REPLACEMENT OF EXISTING DATA STORAGE SYSTEM UNDER BUYBACK OPTION WITH NETWORKING EQUIPMENT AND ACCESSORIES AT NIBMG, KALYANI, WEST BENGAL

The National Institute of Biomedical Genomics (NIBMG) is an Autonomous Institution established by the Government of India, under the aegis of the Department of Biotechnology. This is the first institution in India explicitly devoted to research, training, translation & service and capacity-building in biomedical genomics. It is located in Kalyani, West Bengal, India, about 50 km. from Kolkata.

NIBMG, Kalyani invites sealed tenders from original equipment manufacturers (OEMs)/authorized dealers for the replacement of existing Data Storage system under buy back option with networking equipment and accessories at NIBMG, Kalyani, West Bengal, the equipment details of which is available in **Annexure VII** of the general instructions to Vendor of this notice. The details can be downloaded from the website of the Institute <u>www.nibmg.ac.in.</u>

An amount of Rs 2,80,000 (Rupees Two Lakh Eighty Thousand only) towards earnest money must be deposited in the form of demand draft in favor of National Institute of Biomedical genomics, payable at Kolkata. No interest shall be payable on the earnest money deposited by the bidder. Tender documents without earnest money will be summarily rejected.

Tenders are liable to be cancelled, if any of the terms and conditions contained in the tender document are not complied with. Amendments/corrigendum, if any, in the tender document shall appear only in the website of the NIBMG well before the last date of submission of the tender document.

Incomplete or conditional tenders submitted would be summarily rejected. The Director, NIBMG reserves the right to cancel any or all tenders without assigning any reason thereof. The date of opening of the price bids of technically qualified venders will be announced only in the website of the Institute. Tenders shall be opened in the presence of the tenderers/authorized representatives, if any.

The duly filled tender along with all the required documents must reach the Manager (Administration), National Institute of Biomedical Genomics, (NIBMG), NSS, Kalyani, on or before Feb 13, 2020 by 02.00 p.m. and the technical bid will be opened on the same day at 03.00 p.m.

SCOPE OF WORK:

- 1. Delivery, installation and commissioning of the new storage system, networking component and accessories as mentioned in annexure VII
- 2. Data migration from the existing storage to the new storage
- 3. Installing existing 85 disks into the new system
- 4. Provide support to the existing DDN storage system until the installation of the new system and data migration have been successfully completed. A certificate from DDN for continuation of support must be attached.
- 5. Taking back/removing the old system excluding Rack from the NIBMG campus under the buyback offer.
- 6. 5 years on-site comprehensive warranty for the entire solution including 85 nos. of existing disks and 24 QDR/FDR/EDR cards, connectors, cables for servers, 2 switches/modules for enclosures and software licenses mentioned in annexure VII.

GENERAL TERMS AND CONDITIONS

- **1.** For all purposes relevant to the tender notice, the term "vendor" shall mean, inter alia, both original equipment manufacturers (OEMs) and/or their authorized dealers/distributors.
- 2. This invitation for Bids is open to reputed Foreign/Indian manufacturers or their authorized dealers/sole selling agents/stockiest specifically autorized by the manufacturer to quote on their behalf for this tender. The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 3. National Institute of Biomedical genomics (NIBMG) is registered with Department of Scientific & Industrial Research, Ministry of Science & Technology as a Public Funded Institution for grant of Customs / Central Excise Exemption in terms of Government notification No. 51/96-Customs dated 23.07.1996 and General Excise Duty Exemption in terms of Govt Notification No. 10/97 General Excise dated 10.03.1997
- **4.** The Vendor must have reputed background and should be established in the business (for which the bid is made) for at least 3 years.
- **5.** The Vendor must have Sales Tax Registration No, Service Tax Registration No., Permanent Account No, valid Trade License, Professional Tax certificate and GST No, whichever is applicable. Self- attested copies of these documents must be enclosed with the application. If the vendor is an authorized dealer/distributor/sole authorized distributor as mentioned in point no.1 above, the relevant certificate of authorization (as per format enclosed in **Annexure III** of this notice) from the OEM must be enclosed.
- **6.** All materials supplied shall be new and of good quality. Materials shall strictly comply to specification contained in technical part.
- 7. The Storage OEM must have experience of supplying storage of 2 PB capacity to minimum three reputed scientific laboratories/institutions of higher learning in India for a minimum period of three years. (Please enclose documentary proof in this regard). The supplier shall along with this offer submit a brief list of work of similar nature, quality and value executed by them with regards to the same (year wise segregated).
- 8. All materials in the job shall remain under risk and responsibility of the supplier till satisfactory commissioning and acceptance of work by the purchaser.
- **9.** The supplier shall supply copy of operator's manuals. Manual to include all vendor information , technical details of each individual component as far as possible used in the manufacturing of the system, maintenance manual and part listing along with the reference numbers for procurement of spares and references.
- **10.** Vendor must have 24x7x365 support centre and spares depot in Kolkata.
- **11.** Bidder may visit the Institute on 31st Jan 2020 to know about the existing storage system, existing servers and their connectivity.
- **12.** The Tenderer may visit site to acquaint him of the place where the equipment is to be installed. No escalation/compensation shall be entertained at a later date.
- 13. Price should be quoted in USD on CIP Kolkata basis.

14. Separate Technical Bid and Price Bid duly sealed and superscribed "Documents for the Replacement of existing Data storage system under buy back option with networking equipment and accessories at NIBMG - Technical Bids vide NIT No.: NIBMG/Data Storage System/2019-20/43, dtd.23/01/2020" and "Commercial Offer/Price Bid For The Replacement Of Data Storage Under Buy Back Option with Networking Equipment And Accessories at NIBMG, NIT No. NIBMG/Data Storage System/2019-20/43, dtd.23/01/2020" shall be submitted as per bid details given in this document. Soft copy of Technical Bid document (in a CD and without any price/commercial details) should also be submitted in the technical bid cover. The tender not submitted in the prescribed formats or incomplete in detail is liable for rejection. The Institute is not responsible for non-receipt of bids within the specified date and time due to any reason including postal holidays or delays. The bids should be submitted in the format prescribed below:

ENVELOPE I (Technical Bid):

The Technical Offer should be complete in all respects and contain all information asked for, except prices. Technical Offer should mention that 5 Years Comprehensive Warranty Period is included in the Commercial Offer, without mentioning the actual amounts in the technical offer. The suggested format for submission of Technical Offer is as follows:

- g) Technical Specifications as given in *Annexure VII* complete with all the details filled in. This should not contain any price information.
- h) Technical Documentation (Product Brochures, leaflets, manuals etc.).
- i) Deviation Table as per Annexure VIII
- j) DDN's Certificate for continuation of support for 85 nos. of existing Disks as per Annexure IX
- k) DDN's Certificate for continuation of support for the existing DDN storage system until the installation of new system and data migration have been successfully completed as per *Annexure X*

ENVELOPE II (Commercial Offer/Price Bid):

- a) The Commercial Offer (CO/Price Bid.) should give all relevant price information as per *Annexure XI*. The Bid Form must be filled in completely, without any errors, erasures or alterations and should be printed on the letterhead of the vendor. The Commercial Offer must not contradict the Technical Offer in any way.
- **15.** This tender document is not transferable. Only the vendor who has purchased this tender is entitled to quote. Any change in the constitution of the firm, etc. shall be notified forthwith by the contractor in writing to the tendering authority and such change shall not relieve any former member of the firm, etc., from any liability under the contract.

No new partner / partners shall be accepted in the firm by the contractor in respect of the contract unless he / they agree to abide by all its terms and conditions, and deposits with the tendering authority a written agreement to this effect. The contractor's receipt for acknowledgement or that of any partners subsequently accepted as above shall bind all of them and will be sufficient discharge for any purpose of the contract.

16. The commercial offer should be unconditional and shall hold good for a period of 180 days from the closing date of the tender. Any offer falling short of the validity period is liable for rejection.

- 17. Earnest Money Deposit (E.M.D) of Rs. 2,80,000/- in shape of A/C payee Demand Draft/ Banker's Cheque from nationalized bank/scheduled bank in favor of "National Institute of Biomedical Genomics" payable at Kolkata, West Bengal must be deposited along with the technical bid. The EMD should normally to remain valid for a period of 90 days from the date of issue. Please mention the NIT No., company name and address in the back side of the EMD for our reference. The EMD to the unsuccessful Bidder(s)/Vendor(s) will be returned within 30 days from the date of award of the contract or order. Tenders without EMD will be summarily rejected. No other mode of payment of EMD will be accepted.
- **18.** Each offer should specify only a single solution for each item which is cost effective and meets the tender specifications, and should as far as possible not include alternatives.
- **19.** The cost of the equipment quoted must be comprehensive which should include the following:
 - Cost of the equipment is inclusive of all taxes & statutory duties.
 - If the rates are included of excise duty/customs duty/GST then the rates may be shown separately. It may please be noted that this Institute is exempted from paying of customs duty (as per custom rule, only concessional custom duty will be charged), excise duty and reduced rate of GST by DSIR, Govt. of India.
 - 5 years onsite comprehensive warranty covering all parts & labours. This period will start from the date of installation and successful acceptance of all the equipment's by NIBMG.
 - Insurance of the equipment should cover up to premises i.e. Data center of the customer. (National Institute of Biomedical Genomics (NIBMG), Kalyani, Nadia, West Bengal).
 - Price/ Commercial bid must contain, not only the rates in figures, but must also be expressed in words. Any overwriting/using fluids/cutting in the Price bid will not be entertained. If there is any overwriting/using fluids/cutting in the price section then it should be authenticated (duly signed by the vendor near the same).
 - For imported offers, the exchange rate applicable on the day of Financial Bid opening will be taken.
- **20.** The offers containing unauthenticated erasures or alterations will not be considered. There should be no unauthenticated handwritten material, corrections or alterations in the offer. Technical details must be completely filled up. Correct technical information of the product being offered must be filled in. NIBMG may treat offers not adhering to these guidelines as unacceptable.
- **21.** The vendor may modify or withdraw its offer after its submission, provided that written notice of the modification or withdrawal is received by NIBMG prior to the closing date and time prescribed for submission of offers. No offer can be modified by the vendor, subsequent to the closing date and time for submission of offers. In the event of withdrawal of the offer by successful Vendor, the Institute will forfeit the EMD.
- **22.** To assist in the scrutiny, evaluation and comparison of offers, NIBMG, may at its discretion, ask some or all Vendor for clarification of their offer. The request for such clarifications and the response will necessarily be in writing. If deemed necessary, the vendor is required to give presentation on the systems offered.
- **23.** NIBMG reserves its right to carry out a technical inspection and performance evaluation (benchmarking) of machines offered by shortlisted Vendor
- **24.** NIBMG reserves the right to verify any or all statements made by the vendor in the tender document and to inspect the vendor's facilities, if necessary, to establish to its satisfaction about the vendor's capacity to perform the job.
- **25.** NIBMG, if deemed fit, will inspect any or all of the equipment at vendor's manufacturing site before shipment to verify that the equipment shipped to NIBMG are as per the technical specification specified in the purchase agreement.

- **26.** NIBMG will shortlist technically qualifying Vendor and the commercial offers of only these Vendor will be opened. After opening Commercial Offers of the shortlisted Tenderers, if there is a discrepancy between words and figures, the amount indicated in words will prevail.
- **27.** For the bids surviving the technical evaluation which have been found to be responsive the evaluation & comparison shall be made as under
 - (i) **For indigenous offers:** The final landing cost (CIP Kolkata) of purchase after all discounts, freight, forwarding, insurance, taxes etc. shall be the basis of evaluation.
 - (ii) For imported offers: The final landing cost (CIP Kolkata) of purchase after all discounts, freight, forwarding, insurance, concessional customs duty, taxes etc. shall be the basis of evaluation. For the purposes of comparison, the exchange rate applicable on the day of Financial Bid opening will be taken.
- **28.** NIBMG would like to have the following time schedule for completion of the activities/from the date of placement of orders.
 - Delivery: 5 (five) weeks
 - Installation and operationalisation: 1 (one) week from the date of delivery.
 - The tenderer shall be responsible for proper packing so as to avoid damage, under normal conditions of transport by sea, rail and road or air and delivery of the material in good condition to the consignee at destination. In the event of any loss, damage, breakage or leakage or any shortage the tenderer shall be liable to make good such loss and shortage found at the checking / inspection of the material by the consignee. No extra cost on such account shall be admissible.
- **29.** The Institute may impose liquidation damages @0.5% per week subject to maximum of 5% of the total order value if delivery and installation is beyond the above mentioned period after the issuance of purchase order. Such penalty is to be deducted always from the bills of the firm OR from the EMD/ Security Deposit on the account and risk of the vendor. Once the maximum of the damages above is reached, the Indenter/purchaser may consider termination of the Contract and delisting the vendor on the account and risk of the vendor.
- **30.** The payment terms of NIBMG in context of this tender will be 90% value of the order through Wire Transfer within 07 working days up-on receipt of the material and balance 10% after installation of equipment to the complete satisfaction of the competent authority of the institute (NIBMG).
- **31.** The selected Vendor shall furnish a Performance Guarantee (PG) of 10% of the total cost of the purchase order in the form of Bank Guarantee (*as per Annexure II*) issued by a nationalized Bank within 10 days of receipt of the Purchase Order. On submission of the PG, the EMD shall be released to the selected vendor. The Performance Guarantee shall remain valid till the period of warranty.
- **32.** The contract will be deemed as incomplete if any component of the equipment is delivered but not installed and / or not operational or not acceptable to the Indenter after acceptance testing / examination. In such an event, the supply and installation will be termed as incomplete and it will not be accepted and the Warranty period will not commence. The Warranty period will commence only on acceptance (based on acceptance test) of equipment by the Indenter.

Warranty Period: 5 years onsite comprehensive warranty of the entire Equipment from the date of installation covering all parts & labour. Vendor must have 24x7 support centres for reporting/registration of complaint. In case of defects arising with the equipment in the warranty period, the same must be promptly responded within 1 hour of reporting/registration of complaint and the same must be solved within 24 hours including replacement of spare part, if required. In case of failure of adhering to the time schedule mentioned above the Director, NIBMG, shall have the right to impose a monetary penalty of Rs.10000/- per day.

- **33.** NIBMG also reserves the right to cancel the order in the event of one or more of the following circumstances:
 - Delay in delivery and installation beyond a period of 6 weeks from the date of issue of Purchase order.
 - Serious discrepancy in equipment noticed during the pre-dispatch inspection, if any.
 - Breach by the tenders of any of the terms and conditions of the tender.
 - Any action by the vendor which is in breach of contract, law or accepted practices in commercial transactions.
 - If the Vendor goes into liquidation voluntarily or otherwise.
 - In addition to the cancellation of purchase order, NIBMG reserves the right to forfeit the Performance guarantee/EMD submitted to NIBMG by the Vendor and delisting the vendor.
- **34.** The vendor shall indemnify NIBMG and keep indemnified against any loss or damage that the NIBMG may sustain on account of any violation of patents, trademark etc., by the vendor in respect of the products supplied. The Supplier shall indemnify the Purchaser against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the Goods or any part thereof in India.

35. Shipment advice and shipping documents for imported equipment/article:

Shipment Advice: The shipment details and a set of copy of all shipping documents may please be sent to us as well as to our custom clearing agent sufficiently ahead in order to avoid delay in custom clearance and any damage to the Consignment. Please ensure that all shipping documents mentioned below in original reaches to us prior to the arrival of the consignment at Kolkata Airport/Seaport in order to clear the consignment from the Customs Authority without paying any demurrage charges. The demurrage and other related charges, if any, due to negligence on your part would be borne by you.

Shipping Documents: At least 4 copies with original of all shipping documents including invoice, delivery chalan /packing list, weight list (both net & gross), **Country of Origin certificate issued by a Chamber of Commerce**, insurance documents, pre-shipment inspection certificate [to be issued by the Manufacturer or Beneficiary for item(s) certifying that "the goods conform to the specifications and quality in order No. (Mentioning the Purchase Order No. & Date) of National Institute of Biomedical Genomics, Kalyani" etc. should be sent along with the consignment.

- **36.** NIBMG reserves the right to undertake further pre-tender qualification to identify suitable tenderers for a particular tender list.
- **37. Force Majeure**: The vendor shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that it's delay in performance or other failure to perform its obligations under the contract is the result of an event of force Majeure. For purposes of this Clause, "Force Majeure" means an event beyond the control of the Vendor and not involving the vendor's fault or negligence and not foreseeable. Such events may include, but are not limited to, Acts of God or of public enemy, acts of Government of India in their sovereign capacity, acts of war, acts of NIBMG in fires, floods and freight embargoes.

If a Force Majeure situation arises, the Vendor shall promptly notify NIBMG in writing of such conditions and the cause thereof within twenty calendar days unless otherwise directed by NIBMG in writing, the Vendor shall continue to perform its obligations under the Contract as far as it is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. In such a case, the time for performance shall be extended

by a period(s) not less than the duration of such delay. If the duration of delay continues beyond a period of three months, NIBMG and the vendor shall hold consultations with each other in an endeavor to find a solution to the problem. Notwithstanding above, the decision of The Director, National Institute of Biomedical Genomics shall be final and binding on the vendor.

- **38.** If any cheating or forgery is found at any moment, the Director, National Institute of Biomedical Genomics holds the right to forfeit the EMD or Security money and is empowered to take legal action as deemed fit. NIBMG reserves the right to take action as deemed fit which is inclusive of placing the tenderer under suspension / holiday for a period as decided by its Director in case of withdrawal of offer at any stage , non acceptance of LOI/ PO or non execution of order or any other breach of tender terms and conditions. In case of any dispute in the interpretation of the terms and conditions of the tender, the decision of the Director, NIBMG shall be final and binding.
- **39.** The TECHNICAL BID and PRICE/ FINANCIAL BID after properly sealed (preferably wax/ cello tape seal) in two separate envelopes (super scribed as per instructions in point no. 7 above) should be sent in a single sealed (preferably wax/ cello tape seal) envelope super scribed as *"REPLACEMENT OF DATA STORAGE UNDER BUY BACK OPTION WITH NETWORKING EQUIPMENT AND ACCESSORIES AT NIBMG*, Tender Notice No. NIBMG/Data Storage System/2019-20/43 dtd. 23/01/2020" This envelope may be sent by courier/speed post/registered post addressed to The Section Officer (Administration), National Institute of Biomedical Genomics, P.O.: N.S.S., Kalyani 741251, West Bengal, INDIA so as to reach the address mentioned above by 02:00 p.m. of Feb 13, 2020. The envelope may also be delivered by hand and dropped at the tender box bearing the tender notice no. to be kept at the reception of the Institute. It may be noted that the Institute shall not accept any tender received after the closing hours of the last date for submission of tenders mentioned above. The Institute shall also not take responsibility of returning any tender document received through any mode after the last date and time.
- **40.** During warranty period, vendor will be sole responsible for delivering spare parts; NIBMG will not provide any document for the delivery of spare parts.
- **41.** Existing Storage System details: DDN Grid Scaler 12K storage system with enclosures and disks excluding Rack.
- **42.** Vendor must buyback the existing storage mentioned above. Under buyback, vendor must remove this system from NIBMG campus after successful migration of the data to the new storage system and provide to the institute appropriate reduction in value for the new storage. NIBMG will provide necessary documentation to remove the system.
- **43.** Data migration: The vendor will migrate all the data from the existing system to the new system. If any data loss happens during the migration, the vendor will be responsible for recovering all the lost data.
- **44.** Payment will be released only after successful delivery, installation and commissioning as certified by Officer-in-charge of the Institute.
- **45.** In the event of dispute, Director- NIBMG shall be the sole arbitrator and his decision shall be final and binding on both the parties.
- **46.** NIBMG, Kalyani does not bind itself to accept the lowest or any other offer and reserves the rights to accept, consider or reject any or all bids without assigning any reasons thereof. The decision of NIBMG, in respect of supply of items shall be final and binding on all bidders.
- **47.** All disputes in this connection shall be settled in Kolkata jurisdiction only.
