Earnest Money will be accepted in the form of Bank Draft drawn in favour of the 'NATIONAL INSTITUTE OF BIOMEDICAL GENOMICS', payable at Kalyani on any Nationalised Bank. EMD of the unsuccessful tenderer will be returned after the work order is issued. No interest will be paid on EMD.

Intending Bidders may kindly visit the Institute website www.nibmg.ac.in for downloading the tender documents and for other details.

Eligibility Criteria

Intending bidders should fulfill the eligibility criteria laid down hereunder and they should satisfy themselves about their eligibility before submitting the tender. The bidders should submit the documents/credentials in Technical Bid –I, and only the Rate in the financial bid-II.

- i) Minimum 5 (five) years' experience of successful supply of the furniture in Govt. Organization, Autonomous Institute, PWD, CPWD, State PWD, and reputed organizations for following value of work during last 5 (five) years ending last day of month previous to the one in which tenders are invited.
 - a) Two similar completed works costing not less than Rs. 21 lakhs each.
 - b) One similar completed work costing not less than Rs. 28 lakhs.
- ii) Average Annual Turnover during last 3 (three) years ending 31st March shall be minimum Rs. 20 lacs

- iii) The bidders should also submit the photocopies of following documents in the Technical Bid- I:
 - i) Valid GST Registration Certificate
 - ii) Professional Tax Registration Certificate
 - iii) PAN Card
 - iv) Valid Trade License Certificate

2. Terms and Conditions:

- i) Rate should be inclusive of all taxes, duties on date, levies, insurance, transport cost etc. GST will be paid extra, as applicable.
- ii) New imposition of taxes (other than GST) and other charges will be borne by the Vendor.
- iii) Security Deposit will be deducted @ 5% (Five percent) of the Bill value from each bill and the same will be released against submission of Bank Guarantee after handing over and satisfactory delivery and obtaining completion certificate from NIBMG. The validity of the Bank Guarantee will be Defect Liability Period plus 60 days. Defect Liability period (twelve calendar months) will be reckoned from the date of successful delivery, completion and handing over of the assigned work.
- iv) Performance Guarantee amounting to 5% (Five percent) of the Contract value is to be submitted within 10 (Ten) days in the form of Bank Guarantee from the date of issue the work order and will remain valid up to 1 (One) year plus 60 days after final completion of work in all respect.
- v) No mobilization Advance will be paid.
- vi) The security deposit, and Performance Bank guarantee will be forfeited, at the discretion of the NIBMG authority, if the terms and conditions of the work order are not fulfilled
- vii) The Vendors will also be solely responsible for the security of its material, machinery etc. till the date of handing over of the same.

3. Payment Terms:

- a) 70% payment will be made within 30 days of actual delivery of the furniture against submission of the Bill complete in all respect.
- b) Balance 30% shall be payable after successful installation and handing over to NIBMG of the total furniture as per order.
- **4.** The contractor shall take all necessary action to fulfill all applicable statutory obligations as well as the safety measure of its worker required to execute the work.
- **5.** The work order can be terminated if any of the contract terms are violated by giving 5 (Five) days' notice from the competent authority of NIBMG at any stage of work.

- **6.** All disputes arising out of or in any way connected with this work order shall be deemed to have been arisen in Kolkata and only the Court in Kolkata shall have jurisdiction to determine the same.
- **7.** Tender in duplicate will have to be submitted in two parts Cover-I Technical Bid & Cover-II Financial Bid separately sealed and superscripted with the name of the supply.
- **8.** Cover-I : Cover-I (Technical Bid) shall contain Earnest Money, all documents supporting fulfillment of eligibility criteria & commercial & general stipulations mentioned in the tender documents.
- **9. Cover-II: Cover-II (Financial Bid)** shall contain the complete tender documents duly filled in duplicate. No condition stipulated in Cover-II other than general rebates shall be accepted. The Financial Offer of the prospective tenderer/bidder will be considered only if the Technical Bid of the tenderer is found qualified by the 'Tender Evaluation Committee' of NIBMG. The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect.
- **10.** Pre-bid meeting with the intending bidders will be held on 15.07.2020 at 02:00 PM, at National Institute of Biomedical Genomics, Kalyani.
- 11. Tenders (Cover-I & Cover-II put in a separate sealed cover) will be received up to 12:00 PM on 29.07.2020 and the technical bid will be opened on the on the same day at 02:00 PM/any other day as finalized by NIBMG at National Institute of Biomedical Genomics, P.O. N.S.S, Kalyani 741 251, West Bengal in presence of the Bidders or their authorized representatives who may like to be present.
