Desirable Qualification	Should have capability to conduct research independently in Cancer Biology or Host-Pathogen Interaction or Microbiology or Statistical Genomics using Genomics as the essential tool. The candidate should have documented expertise and publications in any of the following: Genome editing using human cells or any model organism, Single cell/spatial genomics or imaging/microscopic techniques, translational capability, drug screening, usage of pathogenic microorganism.		
Job description	The appointed Assistant Professor will be responsible for running his/her research laboratory to the highest international standards, do teaching of PhD and integrated PhD students, carry out some number of administrative duties. Very generous start up grants will be provided to the successful applicants. The Institute also usually provides very competitive intramural funding as compared to other Institutes in India. However, the candidates have to apply for competitive extramural funds (both in India and abroad) as intramural funding is not guaranteed. He/she shall assist the Director / Associate Directors in such matters as may be determined by the Director from time to time and shall also exercise such powers and perform duties as may be assigned by the Director / Associate Directors.

## **SELECTION PROCEDURE FOR SCIENTISTS**

The selection of Assistant Professor will be done as per the NIBMG Recruitment Rules 2016. It is likely to consist of interaction/Interview. Attaining minimum eligibility does not make the candidate eligible for interview. The Institute will make a final administrative decision in this regard.

The decision of NIBMG regarding scrutiny of applications and shortlisting shall be final and binding. Appointment of selected candidates will be subject to their medical fitness in the Pre-Employment Medical Examination and as per GOI norms.

#### **PAY AND ALLOWANCES:**

Pay & Allowances and other benefits are same as applicable to Central Government

Employees posted in Kalyani/Kolkata or place of posting. The pay and allowances etc. are presently admissible as per the recommendations of 7th Pay Commission of the Govt. of India. **Experience Certificate:** Proof of experience indicating post held, period of service, pay scale/ emoluments & area of experience. (In respect of PSU/Govt. employees indicating revised as well as prerevised pay scales with period details).

Pay Certificate from concerned organization (Govt./ Public/ Private sector) in support of experience in relevant pay scale/ emoluments/ equivalent level.

All proof of experience shall be self-attested by the candidate.

## **GENERAL INFORMATION AND TERMS & CONDITIONS:**

1. Only Indian Nationals/OCI (necessary clearance from MHA and MEA should be

- placed before appointment) are eligible to apply for NIBMG.
- **2.** Before applying, the candidates should ensure that he/she fulfils the eligibility criteria and other norms mentioned in the advertisement.
- **3.** Essential qualifications should be recognized in India and from recognized Institution or University.
- **4.** The experience requirement specified should be the experience acquired after obtaining the minimum educational qualifications required for the post. **Traineeship period will not be counted as experience.**
- **5.** Wherever CGPA/OGPA or Letter Grade in a degree/diploma is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University/Institute.
- **6.** All computations of age, qualification, experience etc. shall be as on the closing date of receipt of applications.
- **7.** If any certificate etc. is issued in a language other than Hindi/English, Candidates are advised to submit a certified translation of the same in either Hindi or English Language at the time of Interview, if called for.
- **8.** Applications that are not in conformity with the requirements indicated in the advertisement, incomplete applications, or necessary documents as prescribed or received after the last date of online application are liable to be rejected.
- 9. Mere submission of Application, fulfilment of the minimum prescribed qualification and experience will not vest any right on a candidate for being called for selection process.
